Course Description:

Welcome to Psychopathology! In this course, you will learn about common mental disorders and their etiology, course, treatment, and diagnostic procedures. Learning activities include lecture, student presentations, and group discussions.

Course Goals & Objectives:

After completing this course, you should be able to:

- Understand and identify major characteristics of common mental disorders.
- Understand the history of the mental disorder classification system (i.e., Diagnostic and Statistical Manual of Mental Disorders) and critically evaluate its strengths and limitations.
- Gain knowledge of common mental disorder's psychological treatment approaches.
- Enhanced awareness in community- and/or nationwide resources/organizations for individuals with mental disorder and their families.

To meet these goals, you are expected to:

- Read chapters and understand course lecture material.
- Participate in class activities and discussions.

General Classroom Expectations:

- You are expected to attend all classes. If you miss a class, it is your responsibility to obtain lecture material and understand the contents covered in class. If you need clarification on any of the material, I would be happy to meet with you during office hours (or other appointment times).
- I know that some of you prefer to take notes on your laptops, which is fine. However, please refrain from being on non-class related websites (e.g., Facebook, Instagram, Message chat, shopping websites). Also, please take off headphones/ earphones when in class.
- If I see non-class related cell phone use during class, I will collect your phone. It will be returned to you at the end of the lecture.

- All the classes will start promptly on time, and you are expected to come to class on time. Repeated late attendance may negatively affect your attendance grade.

Points in this Class

(1) Video Quiz (20 points each x 2 = 40)

You will watch a video during class time on your own and take a video quiz, which is due on the same day. Please see the class schedule for details.

(2) In-Class Activity (total points TBD)

- a. We will have multiple in-class activities. For each activity, I will assign 5 points to participating students (i.e., you were in class and did the activity).
- b. Total points for this activity will be determined at the end of the semester based on the number of activities completed.

(3) Exams (100 points each; 3 exams; 300 total)

1. All three Exams will be online and open book. You will have to complete the exam in one sitting in a given amount of time.
2. Each exam will cover only the material since the last exam (i.e., it is not cumulative). Each exam will cover both lecture topics and information from the assigned readings and will include multiple-choice questions. Be aware that all information presented in both the assigned readings and class lectures may appear on exams.
3. **Exams will be given during this course's class & final exam times during which you should all be available.** Please plan to take the exam early if you know in advance that you are going to miss class that day. For example, you can take Exam 1 before the exam day. Same for the other exams. **If you want to take the exam early, please email me at least 3 days in advance with the following information:**
 - Your full name.
 - The exam you would like to take early (e.g., Exam 1).
 - The date/time you want to take the exam. Please give me a specific 75-minute block (e.g., I would like to take Exam 1 from 1 pm to 2:15 pm on 2/8).
4. If due to unforeseen circumstances, you were unable to take the exam before or on exam day, you will be permitted to take a make-up exam on **the final exam date and time.**

Homework 1: P-Factor Article

1. What is a p-factor? Please explain using your own words (no direct quotes).

2. Did learning about the p-factor change your views about our current understanding of mental disorders in any way? If yes, how? If not, why so?
3. What are some potential advantages that the concept of p-factor will bring to mental disorder research and treatment?
4. What are some potential disadvantages that the concept of p-factor will bring to mental disorder research and treatment?

Homework 2: Intersectionality Article.

1. State two important points learned from this article.
2. Explain why those two points are important to know to advance the field of clinical psychology.

**** Department of Psychology Policy on Withdrawal and Incomplete Grades**

All withdrawals must be completed by the end of the 13th week of classes during fall and spring, and by the end of the 6th week of an 8-week summer term. When students discontinue attending class and do not withdraw from a course they may receive the grade of UW (Unauthorized Withdrawal). The grade of UW will only be given when a student's grade based on the course requirements is an F. The grade of UW is calculated as an F in a student's grade average. The granting of a grade of INC (Incomplete) is not automatic and is available only in cases when a student has completed most of the work required for a class but is prevented by a medical or similar emergency from completing a small portion of the work not later than the end of the following semester. An INC must be approved by the instructor with appropriate documentation provided by the student. If an instructor agrees to give a student an I, the instructor will fill out a Memorandum of Incomplete Grade to be kept with the student's records. If the work is not completed by the time specified on the Memorandum, the student's grade will be changed from INC to F.

** Statement on Plagiarism

Plagiarism includes presenting someone else's words without quotation marks (even if you cite the source), presenting someone else's ideas without citing that source, or presenting one's own previous work as though it were new. When paraphrasing from another source or your own work, at the very least, the student should change the wording, sentence syntax, and order of ideas presented in the paper. Additionally, you should not submit a paper, or parts of a paper, written to fulfill the requirements of one class for the requirements in another class without prior approval of the current instructor and appropriate citation. Ideally, the student will integrate ideas from multiple sources while providing critical commentary on the topic in a way that clearly identifies whether words and ideas are those of the student or are from another source. Plagiarism is one type of academic misconduct described in SIUE's Student Academic Code (<http://www.siu.edu/policies/3c2.shtml>). University policy states that "Normally a student who plagiarizes shall receive a grade of F in the course in which the act occurs. The offense shall also be reported to the Provost."

** Department of Psychology Writing Policy

As a student in this course, you will be expected to display university-level writing, which includes completing course assignments that meet the following basic writing criteria. Specifically, all written assignments completed for this course should include:

- clear transitions from sentence to sentence and idea to idea (e.g., paper is organized/flows well);
- verb tense consistency;
- clear and unambiguous sentences and ideas;
- writing that is free of typos, spelling errors, and major grammatical errors;
- properly formatted citations and references (if relevant).

This is by no means an exhaustive list of basic writing skills, but will give you an idea of what we are looking for in our papers. If your graded written assignments fail to meet the basic writing requirements listed above (and any others found to be appropriate by your instructor), the instructor will stop the grading process and return the paper to you (see below for the specific policy for this class). The penalty for unacceptable writing in this class is as follows: You will receive **no points** for your assignment.

Classrooms, Labs, Studios, and Other Academic Spaces
