General Rules for the Nature Preserve

- Hiking by small groups of visitors and the University community is welcome on **marked trails** during **daylight hours**. On-trail running or jogging by groups of less than five is permitted. Traffic on muddy trails is strongly discouraged. Hiking off trail or at night requires official permission.
- Wheeled vehicles are not permitted except to serve the handicapped, or support teaching, research and management.
- Littering or the possession of alcohol or illegal substances is not allowed.
- Pets must be leashed at all times.
- Removal or alteration of natural materials and historical artifacts requires official permission. This includes picking fruits, nuts or mushrooms, and activities involving painting, marking, carving, digging, vegetation cutting, planting or release of organisms.
- Camping, fires, and building of structures are not allowed.
- Markers, tags, flagging and the like identify educational or student research projects. They are central to the mission of the Preserve, and must not be removed.
- Placement of signs, flags, markers, etc. may only be done by authorized persons.
- The Preserve is closed to hunting and trapping of all kinds without official permission.
- Parties larger than six persons must apply for permission to use the Preserve.

Violations of any of the rules or policies established for the Nature Preserve or the SIUE Campus at large can result in revocation of privileges in the Preserve and legal action.

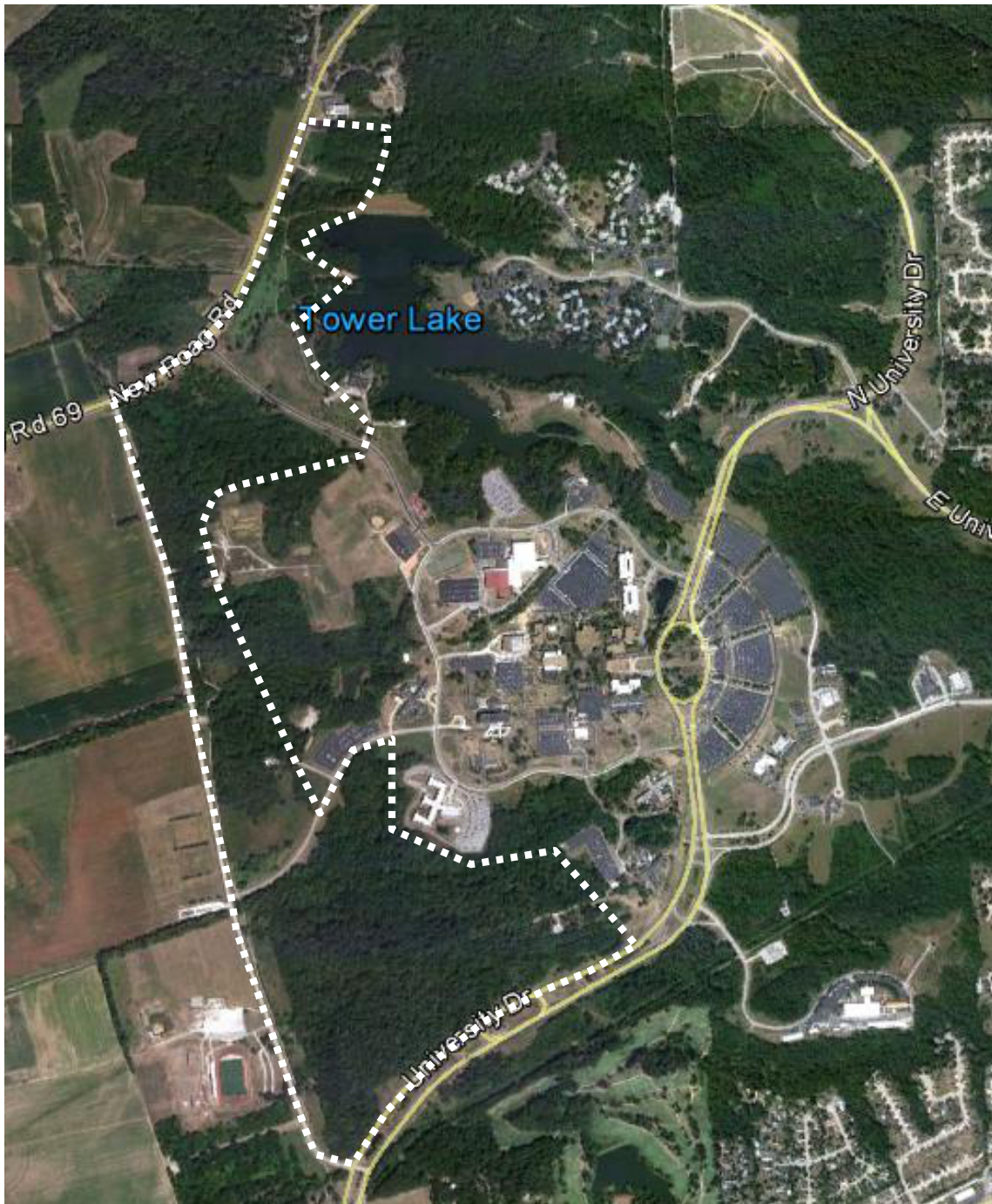


Figure 1. Aerial photograph of SIUE Nature Preserve. Approximate Preserve boundary is indicated by dashed line.

2. Location for your work as either an overlay on an aerial photo, markings on Figure 1, or as latitude and longitude (decimal degrees preferred).

3. Description of your study plan including its proposed starting and completion dates. (These may be modified later if necessary). Be sure to indicate the numbers of such items as marked plots, trees, holes, soil samples, etc.

4. Discussion of the impacts your work might have on wildlife, vegetation, soils, archaeological/cultural artifacts, and aesthetics. Describe how you will minimize or mitigate impacts.

5. Evidence you have obtained permission or required training if your work is regulated by the government or the University (e.g., animal capture, chemical application).

6. Roster of student researchers or assistants with telephone number or email addresses.
