Temko and Jordan presented on Faculty Senate Bylaws. The most recent bylaws approved by the Chancellor created the new University Budget, Finance, and Operations Council, as well as changed the council membership requirements. Temko will present at next week's Faculty Senate regarding Faculty Senate reorganization.

Consideration of Minutes:

The minutes for the May 12, 2022 meeting were approved as written.

Unfinished Business:

Jia went through the agenda for next week's Faculty Senate meeting. Provost Denise Cobb will give a report about the progress to the University's Strategic Plan. Bob Bitter will present on a revision to Policy 11-47. Matthew Schunke will present on the proposal for the General Education Committee. Ezra Temko will present on the Faculty Senate reorganization. Although Faculty Senate was supposed to vote on Modified Feminist Process, this is not a priority for the September meeting; rather, a mock session will be at the October Faculty Senate meeting.

New Business:

The new council, University Budget, Finance and Operations Council, was discussed. It would be helpful if President Jia and President-Elect McCracken attend the first meeting on September 15 so the new committee can get comfortable with the process. In allocating new senators, we don't want to load that council with inexperienced senators.

Jia presented a draft allocation for the new senators, which was approved by the Executive Committee. Governance Council. Theresa Kelly, Mary Macharia and Elizabeth Wiemers will join the **Welfare Council**. Cinnamon VanPutte, Bernadette Sobczak and Bhargav Patel will join the **Graduate Council**.

Adriana Martinez is the only person nominated to serve as Chair of the Faculty Development Council this academic year. Her nomination was approved by President Jia, Past President Wrobbel, and President-Elect McCracken.

Reports:
